

OVIP'S NOKIA WORLD TICKET GIVEAWAY

Official Rules and Regulations

Before entering the Ovi's Nokia World Ticket Giveaway competition, please read these Official Rules and Regulations and the Privacy Policy. If you do not accept them, you are not eligible to participate in the Competition.

ELIGIBILITY

OVIP'S NOKIA WORLD TICKET GIVEAWAY (hereinafter referred to as "the Contest"), brought to you by Nokia Corporation, Espoo, Finland, (hereinafter referred to as the "Sponsor") will be governed by these rules (the "Official Rules"). **You must be at least 18 years of age or of the legal age in your country of residence to be eligible and to participate. No purchase is necessary to enter or win.** The Contest is open to participants/contestants ("Participants") world-wide.

The Sponsor, its subsidiaries, affiliates and agents reserve the right at any time to verify that any and all Participants meet the eligibility requirements in any manner deemed appropriate. The employees and directors of the Sponsor and/or its licensees, advertising, promotion or production agencies and provider companies (and their respective IRS dependents, immediate family members (spouse, children, parents, siblings) and individuals residing in their same household) are not eligible to participate. By participating, Participants agree to these Official Rules and the decisions of the judges, which are final and binding in all matters relating to this Contest.

The Contest is void wherever prohibited or restricted by any mandatory national, state or other government laws in form and language as provided herein and is subject to all applicable mandatory federal (national), state and local laws.

PROGRAM PERIOD

The Contest begins on **August 20 2010 at 02:00 p.m. GMT** and ends on **August 25 2010 at 02:00 p.m. GMT** (the "Program Period").

HOW TO PARTICIPATE

To participate in the Contest, you must

- 1) Provide us a link to your content by tweeting your entry to us @OvibyNokia Twitter channel using #NokiaWorld hash tag. (“Channel”)
- 2) You must have permission to use all content included in your entry (including but not limited to: video, imagery, music and text)
- 3) Be of age 18 years old or above
- 4) Be able to be in the UK from the 13th until the 16th of September 2010 (including valid travel documents)

CONTEST MECHANICS

In order to use the Channel or Site, you must have access to the World Wide Web (Internet) provided by an Internet Service Provider (hereinafter referred to as an “ISP”) of your choosing and you must pay any applicable ISP, operator, service and other fees for such access. Any entry that, in the sole discretion of the Sponsor, is considered inappropriate or unsuitable for publication will be deemed ineligible by the Sponsor.

THE INFORMATION SUBMITTED BY YOU

In case your entry wins, you will be required to provide your personal details so that we will be able to contact you in matters related to delivery of the Prize.

Winners will be notified by DM via their Twitter account used to submit the competition entries. The message notifying the winner of his/her Prize will include a request for his/her preferred mailing address. The winners must respond with his/her preferred mailing address **within 7 calendar days from the e-mail message** failing which the winner(s) shall forfeit the Prize.

The information submitted by you will only be used by the Sponsor, in accordance with the applicable data protection regulations and the Privacy Policy of the Site or respectively Sponsor’s Privacy Policy for the purposes of administrating your participation in the Contest. The information collected by Sponsor will be deleted and destroyed after the end of the Program Period. The Sponsor will not transfer or disclose the information submitted by you to any third parties.

By participating in the Contest and submitting your name, address, city and country of residence, mobile phone number and e-mail address ("Personal Information") you are acknowledging that you fully accept and give your unambiguous consent that the Personal Information collected in connection with your possible win and participation in the Contest may be transferred across international borders to server locations supporting the Channel and Site for the purposes of administrating your participation and ensuring the prizes will be sent to the address you provide and storing the Personal Information submitted by you in the relevant database during the Program Period, which may be located in Europe.

You have the right at any time during the Program Period to review, correct or remove the Personal Information submitted by you following the guidelines provided in the Channel or Site's Privacy Policy.

PRIZES

The two (2) winners of the Contest will each receive the following prize:

- **Travel, sustenance, tickets and lodgings to attend Nokia World 2010 in London, England**

Taxes, if any, related to any Prize are the sole responsibility of the winner.

The Prizes cannot be assigned, transferred, redeemed for cash, or substituted except by the Sponsor, who may, at its sole discretion, substitute any Prize with one of comparable value if the advertised Prize becomes unavailable for any reason.

DETERMINATION OF THE WINNER

The winner/winners of the Contest will be determined by the panel of judges ranking of submitted entries at the Site via links provided by Contestants.

The winners will be announced on blog.ovi.com and, within a blog entry at, w/c 16/08/2010

Winners will be notified by e-mail provided to register to the Channel. The e-mail message notifying the winner of his/her Prize will include a request for his/her preferred mailing address. The winners must respond with his/her preferred mailing address **within 7 calendar days from the e-mail message** failing which the winner(s) shall forfeit the Prize. In the event of such forfeiture, the Sponsor shall

select another winner based on the selection criteria above or dispose of the Prize in any way it deems fit. The Prize shall be delivered to the winner at the address provided by the winner. Such delivery may be by courier service, postal service or other means as determined solely by the Sponsor. The Sponsor shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) in the delivery of the Prize to the winner.

GENERAL RULES

Participation constitutes consent (a) to comply with these Official Rules, the Channel and Application's relevant Site Terms and Privacy Policy, and (b) that the Participant release and hold harmless the Sponsor, their subsidiaries, affiliates, advertising and promotion agencies, and all of their respective officers, directors, employees, representatives and agents from any and all liability or any injuries, including death, loss or damage of any kind arising in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize or participation in the Contest or any Contest-related activities. If a winner is found to be ineligible or not in compliance with these Official Rules, the winner's Prize will be forfeited and an alternate winner selected.

RIGHT TO USE ANY SUBMITTED CONTENT

It is understood that by submitting, any entry to the Contest (hereinafter referred to as the "Content") to the Channel, Sponsor gets the option but no obligation to have a non-exclusive, royalty-free and free of charge, perpetual, worldwide, irrevocable, and fully sub-licensable right to use, Content in relation to marketing and promotional materials, subject to separate agreement between participant(s) and Sponsor. With regard to such Content submissions, you understand and agree that you are solely and fully responsible for any and all aspects of the Content submitted, including but not limited to its legality, appropriateness and non-infringement of third party intellectual property rights, and the Sponsor shall not be liable in any way for such Content. The Sponsor shall have no obligation to monitor any of the Content provided by you to the Sponsor, but may do so at its discretion.

RULES FOR CONTENT SUBMISSIONS

You also agree that, in addition to any terms that govern your usage of the site where you upload and submit your entry:

(a) you will not publish, transmit, distribute, or upload any information through the Channel or Application or Contest that is unlawful or fraudulent, or violates or infringes any patent, **copyright**, trademark, trade secret or any other intellectual property rights of others. You represent and warrant to the Sponsor that your content does not infringe any intellectual property rights of any third parties;

(b) the Content will not contain any material that is unlawful, libelous, slanderous, defamatory or invasive of another person's right of privacy or right of publicity, or that the Sponsor may reasonably deem harmful, vulgar, obscene, derogatory, pornographic, abusive, harassing, threatening, hateful, objectionable with respect to race, religion, creed, national origin or gender, or otherwise unfit for publication;

(c) you will not send any such messages to any other user or the Sponsor that contain vulgar, abusive or otherwise inappropriate language;

(d) you will not disrupt the flow of discussion with vulgar, abusive or otherwise inappropriate language, or by other means, including without limitation hitting the return key repeatedly or posting repetitive text;

(e) you will not, without first using reasonable efforts to scan and remove any viruses or any contaminating or destructive features before submitting any Content to the Channel, Application and Contest, post, publish, transmit, distribute, or upload any information through the Channel, Application or Contest that contains a virus, Trojan horse, "sniffer" routines, or any other harmful technologies, or other contaminating or destructive features;

(g) you will not use the Channel to "stalk" or harass another person and your Content and use will not suggest or encourage to any illegal activity;

(h) your use of the Channel or Application will not compromise the security or integrity of the Sponsor's computer systems, networks or web site(s) or servers, whether by allowing intruders into the same, introducing viruses or other threats, imposing a disproportionate or unreasonably large load on this Site or its infrastructure, or using any other action or technology to damage or interfere with the operation of the Site;

(i) you will not post, publish, transmit, distribute, or upload through the Channel, Application or Contest any unauthorized or unsolicited bulk e-mail solicitations, chain letters, advertisements, marketing or promotional materials, "junk mail", "spam", pyramid schemes or any other solicitations or communica-

tions, including without limitation spamming the Sponsor or other users of the Channel or Application or use or collect other users e-mail addresses or phone numbers, or other users information or postings, or use the Channel to perform any data collection, extraction or mining or gain or attempt to gain unauthorized access to Sponsor's or any site visitor's computer system;

(j) you will not provide or otherwise use a false name, identity or e-mail address, impersonate any person or entity, including without limitation the Sponsor's or its licensors' personnel, falsely state or otherwise misrepresent your affiliation with a person or entity, use another user's password (if applicable), forge headers or otherwise manipulate identification information to falsify or disguise the origin of any Content, or falsify or misrepresent any Content with respect to submissions to the Site, and

(k) you will follow all applicable laws and regulations applicable to your use of the Application and/or Content submission. Only as a reminder, such laws and regulations include those governing copyright, defamation, privacy, publicity and the access or use of others' computer or communication systems.

Additionally, you agree that you will use good judgment and exercise discretion in choosing appropriate subjects and subject matter for any audio submissions to the Channel, Application or Contest. **Remember that privacy laws may protect individuals with respect to their being recorded, so please respect the privacy of others by asking for and obtaining their consent to be recorded, as well as for your submissions of voice recordings to the Site and Contest.**

INTERNET

Neither the Sponsor nor its subsidiaries, affiliates or agencies are responsible for lost, late, misdirected, unintelligible, interrupted or unavailable satellite, network, server, ISP, website, telephone or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, corrupted, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures, technical errors or difficulties, or other errors of any kind whether human, mechanical, electronic or network or the incorrect or inaccurate capture of entry or other information or the failure to capture any such information. Any use of robotic, automatic, macro, programmed or like entry methods will void all such entries by such methods, and disqualify any entrant using such methods. The Sponsor is not responsible for injury or damage to Participants' or to any other person's computer related to or resulting from participating in the Contest or downloading materials from or use of the website. Should any portion of the Contest be, in the Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention,

technical failures or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, the Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Contest, and select the winner from entries received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. The Sponsor is not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest, and assumes no responsibility for any error, interruption, deletion, defect, delay in operation, or transmission, communications line failure, theft or destruction, or unauthorized use of the Site or other applicable sites.

MISCELLANEOUS

These Official Rules are governed by the laws of Finland.

To the maximum extent permitted by applicable law, the Sponsor reserves the right at its sole discretion to amend, withdraw or revise these Official Rules and the Prizes at any time without notice and in such event the Sponsor shall not have any liability whatsoever.

You acknowledge and agree that you must conduct yourself in a mature and decent manner to other Participants, chat room spectators, and the Sponsor. You acknowledge and agree that the Sponsor is permitted to automatically disqualify any Participant that is acting in an unreasonable manner (to be determined in the sole and absolute discretion of the Sponsor on a case by case basis).

You acknowledge and agree that no form of cheating will be tolerated. Any persons found cheating, as determined in the sole and absolute discretion of the Sponsor, will immediately be disqualified from the Contest. Cheating includes but is not limited to tampering, hacking of website, playing the Contest without meeting the eligibility requirements, using any automated software or device to gain an advantage during the Contest, using any cheat codes, exploiting any software bugs, use of the Contest beyond the defined rules of the Contest, attempting to disable or overwhelm any of the Sponsor sites, attempts to disrupt any portion of the Contest, including but not limited to allowing somebody else to use your Personal Information tampering with entry process or operation of promotion or website.

CONTEST OF SKILL

You acknowledge and agree that the Contest is one of skill not chance, and that you have little chance of winning without the skill to make a video that will be valued by the panel of judges.
